2024 RMACRAO BUSINESS MEETING - Thursday, July 11, 2024 at the University of Denver in Denver, Colorado

CALL TO ORDER at 1:00 p.m.

President Katie Rendon called to order the 2024 Annual Business Meeting of the Rocky Mountain Association of Collegiate Registrars and Admissions Officers at the University of Denver campus in Denver, Colorado.

Quorum was established yesterday at the start of the annual meeting. A quorum for any Association meeting, annual or special, shall include the presence from at least one delegate from 25% or more of the member institutions, with each state represented by at least one institution. As President, Katie determined through consultation with the LAC Chair and Vice Presidents that a quorum exists under the RMACRAO bylaws.

It's also important to remind everyone of our bylaws with regard to voting. Per section 2.10:

- Each institution has a number of delegate votes (2-8) based upon enrollment numbers;
- In order to vote, an institutional member must have an individual member present to cast a vote at the meeting;
- Each institution should decide prior to the vote, how its votes will be cast;
- Each institution will select an individual member who will cast the vote of the institution when the balloting begins.

MINUTES FROM THE 2023 Annual Meeting

Secretary Sage Thao, presented the 2023 Annual Business Meeting Minute to the membership for revision and/or approval. Copies of the minutes were sent to our attendees prior to this meeting.

Katie Rendon, President, called for any corrections to the minutes. Hearing no corrections, Katie called for the vote.

- No objections, and the motion carried. The 2023 Business Meeting Minutes were approved as presented.

TREASURER'S REPORT

Treasurer Adela Smith and Comptroller Jerry Becker presented the RMACRAO Budget Report for 2023-2024 and the 2024-2025 Proposed Budget to the membership for acceptance. The Board of Directors proposed a 25% due increase This will allow for a cushion to maintain and fund RMACRAO professional development. A vote will take place at the 2025 RMACRAO annual meeting and if passed the increase will take effect in 2026 The last increase to dues were done around 2006, which changed it from \$50-\$60.

It was also noted that due to the Fiscal year ending on September 30th, we may need to alter the expected line items in October for the current year budget expenditures.

- A motion for approval of the 2024-2025 Proposed Budget was presented by Linda Nichols, and seconded by Kristy McCormick
- o Discussion or revision of the 2024-2025 Proposed Budget
- Scott (Mines): How will budget be impacted if no increase? Answered by Jerry Becker: We have a cushion, however, in the future an increase. We as the Board of Directors need to evaluate the budget/membership every year but this does not mean a increase to dues/membership every year.
 Suggested by Miori Gidley: We can put in a percentage increase within the bylaws. Comment by Kristy World McCormick: The increase makes sense as it justifies for board members to do more with in RMACRAO. Such as seminars, webinars, workshops, etc.
- Budget for 2024-2025 was approved as presented by majority vote.

PRESIDENT'S REPORT

Katie presented a report of the association happenings for the past year.

- We were excited with the sessions that our membership stepped forward to present during the 2023 annual meeting in Albuquerque. We had a wonderful turnout for the meeting with 90 attendees joining what was our first in-person meeting since COVID.

We are grateful that Miori Jackson Gidley, former RMACRAO Secretary and Past President, answered the call and we welcome her as our new Marketing and Communications Coordinator. This position is appointed by the President per our Bylaws. We had the Board consider Miori's letter of interest before filling this position. Please welcome Miori back to the Board.
- This year, RMACRAO has made a concerted effort to bring more regularly scheduled programming to the membership. We have hosted 6 free webinars and one cross-institutional work group for the membership since the 2023 Annual Meeting. We plan to continue this trend into next year. If you have ideas for programming you'd like to see, please be sure to enter that feedback in your end of conference survey.
